

## 2021 – 2022 Tax Information for Residents of the Town of East Troy

All taxes real or personal must be paid in full or the first installment paid on or before - **January 31, 2022**.

The **FASTEST** and most **EFFICIENT** way to pay your tax bill is to **mail** a check or money order made payable to the: **Town of East Troy Treasurer**:

**Taxes are due January 31, 2022. December postmarks are just for income tax purposes, not a property tax deadline.**

**If you require a Receipt, please** enclose a **STAMPED** self-addressed envelope for a receipt to be mailed to you, **OTHERWISE - a receipt will not be mailed to you.** Receipts can be printed from the Walworth County WI website, under Services, "Real Estate & Personal Property Tax Search."

A **LOCK BOX** located in the lobby of the town hall is available **24 Hours** a day. Payments may be deposited in the lock box and a receipt will be mailed, **IF** a stamped, self-addressed envelope is enclosed.

You may pay your taxes **IN-PERSON** at the East Troy Town Hall located at N9330 Stewart School Road on the following dates:

### December 2021

**December 20 to December 22, 2021-- 9:00 A.M. to 1:00 P.M.**

**There will be NO tax collection on December 23 or December 24, 2021 and the Town Hall will be closed.**

**December 27 to December 30, 2021-- 9:00 A.M. to 1:00 P.M.**

**December 31, 2021 – 9:00 A.M. to 12:00 P.M.**

### January 2022

**The Town Hall will be closed January 3, 2022.**

**Tuesday through Thursday -- 9:00 A.M. to 1:00 P.M.**

**Final Day of In-person collection will be January 31, 2022 till 1:00 P.M. Mailed payments postmarked January 31, 2022 will be considered timely.**

### Second Installments

**Are payable to Walworth County and should be mailed to the County by July 31, 2022.**

**Do Not** mail or drop off your payments at the Town for that payment.

As required by the State of Wisconsin, the Town of East Troy maintains a list of persons who submit a request to receive notice of any proposed zoning action that affects the allowable use of the person's property.

If the Plan Commission completes action on any zoning proposal, and the Town Board is prepared to vote on the zoning ordinance, the Town Board shall send a notice, which contains a copy or summary of the proposed zoning ordinance, to each person on the list whose property, the allowable use of which, may be affected by the zoning ordinance. An ordinance may take effect even if the Town fails to send the notice. (Wisconsin Statutes Section 61.35 and 62.23(7)(d)(4).
