Public Hearing for 2020 Budgets

The Public Hearing and Special Meeting of the Electors, on the proposed 2020 Town of East Troy Sanitary District #3, Landfill and Town Budgets, was called to order by Chairman Klarkowski at 5:31 p.m. In attendance were Chairman Klarkowski and Supervisors Montez and Church, Chief Jensen, Clerk/Treasurer Buchanan, Officer Jagielski and resident John Murphy. Discussion took place regarding the three proposed budgets.

Special Meeting of the Electors

Chairman Klarkowski called the Special Meeting of the Electors to order at 5:40 P.M.

For Sanitary District #3, Supervisor Church made a motion to approve the 2020 Sanitary District #3 Budget and Supervisor Montez seconded. Motion approved. (Only Town Board members and members of the Sanitary District are entitled to vote on this budget.)

Resident John Murphy moved to approve the 2020 Landfill Budget. Supervisor Montez seconded and motion passed unanimously.

The 2020 Town Budget will increase by 4.0% with a 3.0% increase of the levy required. Resident John Murphy made a motion to approve the 2020 Town of East Troy Budget of \$3,059,261.00 and adopt the 2019 Tax Levy to be paid in 2020 of \$1,692,370.00. Supervisor Church seconded and motion passed unanimously with a five (5) to zero (0) vote.

Clerk/Treasurer Buchanan moved to adjourn. Supervisor Church seconded and motion passed. Meeting adjourned at 5:42 p.m.

Special Town Board Meeting

A Special Town Board Meeting was called to order at 5:43 P.M. by Chairman Klarkowski. Supervisors Church and Montez were in attendance. Also in attendance were Chief Jensen, Clerk/Treasurer Buchanan, Officer Jon Jagielski and resident John Murphy.

Chairman Klarkowski moved to adopt the 2020 Sanitary District #3 Budget as presented. Supervisor Church seconded and motion passed.

Chairman Klarkowski moved to adopt the 2020 Landfill Budget as presented. Supervisor Church seconded and motion passed.

Supervisor Montez moved to adopt the 2020 Town Budget as presented. Supervisor Church seconded and motion passed.

Supervisor Church stated that she hoped that Town residents realized how the Town tries to do its best for the residents and thanked Clerk/Treasurer Buchanan for her efforts with crunching the numbers.

Supervisor Montez moved to adjourn at 5:45 P.M. Supervisor Church seconded and meeting was adjourned.
