Town of East Troy

November 14, 2022 Public Hearing for 2023 Budgets

The Public Hearing and Special Meeting of the Electors, on the proposed 2023 Town of East Troy Sanitary District #3, Landfill and Town Budgets, was called to order by Chairman Klarkowski at 5:38 p.m. In attendance were Chairman Klarkowski, Supervisors Church, Reyes, Wales and Wucherer, Clerk/Treasurer Buchanan, Deputy Clerk/Treasurer Loth, DPW Superintendent Scheel, Police Chief Gorecki and 52 residents/guests. Discussion took place regarding the three proposed budgets.

Special Meeting of the Electors

Chairman Klarkowski called the Special Meeting of the Electors to order at 6:36 p.m.

For Sanitary District #3, Supervisor Church made a motion to approve the 2023 Sanitary District #3 Budget. Supervisor Wales seconded and the motion passed with a vote of 5 aye and 0 nay votes. (Only Town Board members and members of the Sanitary District are entitled to vote on this budget.)

Resident Bill Hudson moved to approve the 2023 Landfill Budget. Resident Pat Hudec seconded and the motion passed unanimously.

The 2023 Town Budget will increase by 12% with an 8% increase of the levy required. Resident Jon Jagielski made a motion to approve the 2023 Town of East Troy Budget of \$4,468,330.00 and adopt the 2022 Tax Levy of \$1,896,537.00 to be paid in 2023. Supervisor Church seconded and motion passed unanimously.

Chairman Klarkowski reviewed points of information regarding the need for the Town Police Garage building and following that, a motion by Pat Hudec, seconded by Bill Hudson, to build a new Town Police Garage per Section 60.10(2)(f) Authorize Town Board to increase the amount spent on previously authorized Police Garage from \$200,00 to \$500,000 to meet the needs of the Town DPW, Police Department and Administrative offices. Following the discussion, a paper ballot vote was taken with 41 Yes votes and 10 No votes. Motion passed.

Resident Pat Hudec moved to adjourn. Supervisor Church seconded and motion passed unanimously. Meeting adjourned at 7:11 p.m.

Special Town Board Meeting

A Special Town Board Meeting was called to order at 7:11 p.m. by Chairman Klarkowski. Supervisors Church, Reyes, Wales and Wucherer were in attendance. Also in attendance were Clerk/Treasurer Buchanan, Deputy Clerk/Treasurer Loth, DPW Superintendent Scheel, Police Chief Gorecki and 52 residents/guests.

Supervisor Church moved to adopt the 2023 Sanitary District #3 Budget as presented. Supervisor Reyes seconded and motion passed unanimously.

Supervisor Reyes moved to adopt the 2023 Landfill Budget as presented. Supervisor Church seconded and motion passed unanimously.

Chairman Klarkowski moved to adopt the 2023 Town Budget as presented. Supervisor Reyes seconded and motion passed unanimously.

Clerk/Treasurer Buchanan read Resolution 2022-11 Appropriating and Levying the necessary Funds for the Operation of the Government and Administration of the Town of East Troy for the Fiscal year 2023. Supervisor Church moved to approve Resolution 2022-11 with two corrections. Supervisor Wucherer seconded. Motion passed unanimously.

Motion by Supervisor Reyes, seconded by Supervisor Church to adjourn. Motion passed unanimously. Meeting adjourned at 7:15 pm
